## Showcase your university's research output

- Dissertations and Theses are valuable research that should be made visible and connected to your institution
- More and more of this content is submitted in digital form (ETDs) and made available on Open Access institutional repositories
- Cover a great variety of research subjects
- Contain great level of detail
- Important also for other PhD students

- In many countries/ institutions still high % of print submissions
- No university-wide standards
- Variety of legal issues Copyright, embargo requests, publisher contracts



## Author Submission to ProQuest

#### **Submission**

Dissertation/thesis author supplies abstract and keywords

## Editor checks metadata

#### **Quality Check**

Editorial team of subject matter experts reviews metadata and quality of each submission.

## Discovery enhancements

#### **Enhancements**

Editorial team supplements the submission with additional keywords and subject terms from ProQuest's controlled vocabulary for maximum exposure.

# Metadata & PDF ingested and searchable

#### Ingest

Dissertation/thesis is ingested into the PQDT database and is fully searchable!

ProQuest Dissertations and Theses offers an additional distribution channel and complements the deposit on an OA institutional repository.



## Visibility via ProQuest and beyond

ProQuest provides thesis citations to all major subject indexes, expanding the reach of your university's research.


















## Digital Archiving and Access Program for Print

### Indexing


- Titles are sent to our main facility in Ann Arbor, Michigan
- Bibliographic data entered into ProQuest dissertation products
- MARCs generated and delivered to the library

#### **Preservation**

- · ProQuest creates microfilm for each title
- · Negatives will be preserved in ProQuest's vaults
- Microform copies for use on campus are available

### **Discoverability**

- Digital copies are created from the microfilm
- Availability through your Institutional Repository, Dissertations & Theses @ and ProQuest Dissertations & Theses database










### How to submit to ProQuest – Institutions I

### **ETD Administrator**


- Free online submission and transfer of ETDs
  - Authors register, complete metadata fields, confirm publishing agreement and submit PDF
  - Institutional administrator reviews and approves
  - PDF is submitted to ProQuest (and to university repository) for dissemination

## ELECTRONIC THESES & DISSERTATIONS DIGITAL REPOSITORY AGREEMENT

This Digital Repository Agreement is between the University of Southern California on behalf of its USC Libraries ("USC Libraries") and you the Student ("You"), and covers the terms and conditions for the deposit of your scholarly work ("Work") in the USC Digital Repository maintained by the USC Libraries. Together, we agree on the following:

- That You accept the following terms and conditions for the Work you are about to upload
  to the USC Libraries.
- You grant to USC Libraries a perpetual, worldwide, non-exclusive, no-charge, royalty-free, irrevocable copyright license to electronically store, reproduce, prepare derivative works of, and publicly display and distribute the Work. You grant to USC Libraries the right to use your name in connection with the Work.
- USC Libraries will maintain your Work on its USC Digital Repository or at such other
  areas as it may determine, such as ProQuest Dissertations and Theses (see the ProQuest

## PhD and Master's Dissertations and Theses Dissemination Agreement

This Agreement is between the author (Author) and ProQuest LLC, through its ProQuest dissertation business (ProQuest). Under this Agreement, the Author grants ProQuest certain rights to preserve, archive and disseminate the dissertation or thesis, abstract, and index terms (the Work) provided by Author to ProQuest.

### License for Inclusion of the Work in the ProQuest Program.

Grant of Rights. Author hereby grants to ProQuest the non-exclusive, worldwide right to reproduce, distribute, display and transmit the Work (in whole or in part) in such tangible and electronic formats as may be in existence now or developed in the future. Author further grants to ProQuest the right to include the abstract, bibliography and other metadata in the ProQuest Dissertations and Theses database (PQDT) and in ProQuest's Dissertation Abstracts International and any successor or related index and/or finding products or services.

ProQuest Dissemination Program – Election and Elements. The rights granted shall be subject to the following additional requirements:

Redistribution of the Work. Except as restricted by the Author, the rights granted by the Author automatically include (1) the right to allow sale and distribution of the Work, in whole or in part, by agents and distributors, and (2) the right to make the Abstract, bibliographic data and any metadata associated with the Work available to search engines and harvesters.

#### Restrictions.

ProQuest will use commercially reasonable efforts to restrict the distribution of the Work as provided under the publishing option selected by Author or as later elected by Author through direct contact with ProQuest. Such election is subject to Author's Degree Granting Institution Directives (see below). With respect to restrictions requested after submission of the Work, Author acknowledges that ProQuest cannot recall or amend previously distributed versions of the Work.

#### Removal of Work from the Program.

ProQuest may elect not to distribute the Work if it believes that all necessary rights of third parties have not been secured. If Author's degree is rescinded, and the degree-granting institution so directs, ProQuest will expunge the Work from its publishing program in accordance with its then current publishing policies.

The Author will retain the right to remove the work from the ProQuest program. ProQuest will remove the Work upon written request from the Author.
